Prof French has been involved in more than 6,000 forensic cases involving speech and audio analysis, and in criminal matters has accepted instructions from both prosecution and defence. In addition to UK jurisdictions, he has provided evidence for cases being heard in countries including Eire, France, Spain, Austria, Germany, Netherlands, Switzerland, Ukraine, Belarus, Russia, Greece, Portugal, Ghana, Gibraltar, Israel, India, Hong Kong, South Africa, Uganda, Zambia, Pakistan, Malaysia, Singapore, Australia, New Zealand, Mauritius, Canada, USA, Norway
